PARADE RULES:

Any group not following these safety rules may be removed from the Parade,and will not be allowed back in future year's.

1. Maintain forward motion and 50' – 100' interval at all times.
2. If your group does performances,you are limited to 3 minutes at each stop, with a maximum of 3 stops on main st,and 1 stop on Fourth St. PLEASE follow this rule to help the parade flow smoothly.
3. No political floats or persons will be allowed to participate.
4. **ABSOLUTELY NO THROWING OR DISTRIBUTING OF CANDY, FAVORS WHICH MIGHT ENTICE CHILDREN INTO THE STREET OR ADVERTISING MATERIAL OF ANY KIND BEFORE OR DURING THE PARADE.** Any group not willing to follow this rule will not be asked back in future years.
5. Units are not to display price tags, "for sale" signs or sales pitches. An appropriate sign of "who you are" will be acceptable.
6. **Motorized Vehicles may not perform routines,exceed 15 MPH or operate more than 16 feet on either side of the street's centerline.**
7. You are responsible for making arrangements for semi and trailer use as well as a driver.
8. You are responsible for leaving the staging area in the same condition you find it when you arrive.
9. **FIRE DEPARTMENTS: ABSOLUTELY NO SPRAYING WATER ON SPECTATORS! NO SPRAYING WATER ON STREET FOR SAFETY REASONS.**
10. All **Animal Units** (i.e. Horses, dogs, etc.) are responsible for clean up of feces.

**THESE RULES WILL BE STRICTLY ENFORCED.**

**Units in violation may not be asked back in future year's parade.**
